Datix Safety Alerts software has been designed to help you disseminate communications from the Department of Health's Central Alerting System (CAS), the Medicines & Healthcare products Regulatory Agency (MHRA) and the National Patient Safety Agency (NPSA). You can also use Datix to distribute communications from your own or other organisations, including internal security alerts and NICE guidance.

Broadcast information about medical devices and other safety issues, automatically recording responses and formulating action plans.

## Information distribution using Datix safety alerts module

Users at each level in the cascade will record a response which is read by the user at the level above them. In the below example, the junior managers will add a response which is read by the senior manager above them. Those senior managers will gather the responses from their junior managers and record their own response, which will be read by the Safety Alerts Coordinator. There is no limit to the number of levels to which an alert can be cascaded.
